Registrar(Legal Cell) of this University in CWP No. 29867/2017 vide which it has been ordered that 'the operation of the notification shall remain stayed qua the petitioner institutes only' and adjourned to 16.02.2018.

In this connection, it is to inform you that the Kanya Gurukui Mahavidyalya(Vidyapeeth), Panchgaon, Distt. Bhiwani/Ch. Dadri had granted Associate Status by this University and after changing of jurisdiction, the record/files of the said College was handed over to C.B.L.University, Bhiwani. However as per data available in the office supplied by the College concerned, the Vice-Chancellor has fixed the seats in the following Courses as mentioned against each w.e.f. the session 2017-18:-

- 80 seats for Shastri-1 w.e.f. the session 2017-18.
- 80 seats for Uttar Madhyama-I w.e.f. the session 2017-18. 2.
- 80 seats for Purva Madhama-I w.e.f. the session 2017-18.

Further, it is pertinent to mention here that this Office has already complied the orders of the Hon'ble Court by maintaining SAP Portal. But the opening of Panel and fee related issues related to University Computer Centre and Fee Section, Accounts branch of this University.
