**Sub: Withdrawal of provisional affiliation of I.T.S. College, Bhiwani (Haryana) w.e.f. the session 2018-19.**

Sir/Madam,

It is stated that on the basis of provisional No Objection Certificate (NOC) granted by the State Govt. and as per recommendations of the Inspection committee given in its report this University granted the conditional provisional affiliation for establishment of new Degree College in the name and style of I.T.S. College, Bhiwani for running B.A., B.Com., B.Sc. (Medical), B.Sc. (Computer Science), B.Sc. (Hons. Physics), B.Sc. (Hons. Chemistry), B.Sc. (Hons. Mathematics) and B.Sc (Non-Medical) courses on SFS basis w.e.f. the session 2016-17 subject to the condition that your college shall fulfill/complete all the condition/deficiencies mentioned in the report, as well as in the affiliation letter dated 19.07.2016 and also subject to fulfillment of all the conditions laid down by the State Govt. in the Provisional No Objection Certificate (NOC). This conditional provisional affiliation was also further extended from time to time with certain conditions to be fulfilled by your college.

Now the State Govt. vide letter dated 15.11.2018 (copy enclosed) has decided to withdraw the provisional NOC issued to your college due to the reasons mentioned in the letter and also requested to Ch. Bansi Lal University, Bhiwani to withdraw the provisional affiliation to your said degree college and requested that the college may be debarred from making further admissions and students studying in your college may be transferred to neighboring Govt./Aided Colleges. The letter of the State Government has been forwarded to this University by Ch. Bansi Lal University, Bhiwani for information and taking further necessary action because as per the latest interim orders of Hon'ble Punjab and Haryana High Court your college has been allowed to continue under the jurisdiction to this University subject to final outcome of court case.
