In compliance with the above resolution, the Vice Chancellor constituted a committee consisting of following members to devise a permanent mechanism for revision of fee structure on annual basis

- 1. Director, DDE, M.D. University, Rohtak
- 2. Registrar, M.D. University, Rohtak
- 3. Controller of Examination, M.D. University, Rohtak
- 4. Co-ordinator, DDE, M.D. University, Rohtak
- 5. Finance Officer, M.D. University, Rohtak

A meeting of the committee was held on 18.04.2019 at 3.00 pm in the o/o Director, DDE for the above purpose. The committee recommended as under:

RESOLVED THAT 5% FEE OF TOTAL FEE ROUNDED TO NEAREST MULTIPLE OF 50 (FIFTY) MAY BE INCREASED IN VARIOUS COURSES RUN THROUGH DISTANCE EDUCATION MODE FROM THE ACADEMIC SESSION 2019-20 FOR NEW BATCH EVERY YEAR. HOWEVER, THIS INCREASED AMOUNT OF FEE MAY BE INCLUDED IN OTHER CHARGES.
