In continuation to this office letter no 3/31-2018 sch-2 dated 11.07.2019, I have been directed to inform and further direct you that no fee and funds are to be charged from the Schedule Caste Students who are eligible under the Post Matric Scholarship Scheme for SC students at the time of admission in the academic year 2020-21 and further the action may be taken in consonance to the letter no. E:u.1/2018/30135-160 dated 01.09.2018 issued by the Director Welfare of SC/BC Department Haryana, Chandigarh.

"It has come the notice of the Department that some Universities/Aided/SFS colleges charging Fee and funds from eligible SC Students. If any college charging fees funds from SC Students, kindly refund their fees to them. If required, institution may take an assurance from such students that they will deposit the fee to institutions as and when they receive the same in their account through DBT⁴.

Strict compliance of these directions shall be made and in case any deviation is observed strict action may be initiated against the defaulter institution.
