The Committee deliberated upon the various issues relating to Admission to 3 Year, 4 Year, 5 Year and 6 Year Integrated Programs and 2 Year P.G. Programs along with LLB 3-Year Programs being offered in various UTDs and MDU-CPAS Gurugram along with large number of requests received from candidates majorly with regard to change of reservation category and from supernumerary seats to general and vice versa for the session 2021-22.

After considering the matter in detail the Committee noted that point no. 3 of the Prospectus of the above Programs as provided in section 1 (KEY DATES FOR THE ADMISSION PROCESS) which provide as under:

- 3. No change will be allowed in the following fields after submission of application form:
 - i) Candidate's Name
- ii) Father's Name
- iii) Mother's Name

- iv) Date of Birth
- v) Reservation Category vi) Program
- vii) Supernumerary Seat/Quota.

In view of the above rules the Committee made the following recommendations:

For 3-Year, 4-Year, 5-Year and 6-Year Integrated Programs:-

1. Physical counseling for vacant seats if any will be held on 20.09.2021 as already notified in the Prospectus. Hence the candidates who have submitted their application form in time and their application have been found in order and they figured in the Merit List, they may be considered first for physical counseling. However, on the sympathetic grounds the candidates who have requested for correction in the categories may be considered if seats remain vacant. The process for physical counselling will be as under:

- i) In the fore noon on 20.09.2021 the physical counseling be held whose names have already been mentioned in the merit list. They will be required to pay the fee online upto 21.09.2021.

For 2-Year P.G. Programs and LLB 3-Year Programs:-

- 1. Physical counseling for vacant seats if any will be held on 13.10.2021 as already notified in the Prospectus. Hence the candidates who have submitted their application form in time and their application have been found in order and they figured in the Merit List, they may be considered first for physical counseling. However, on the sympathetic grounds the candidates who have requested for correction in the categories may be considered if seats remain vacant. The process for physical counselling will be as under:
- i) In the forenoon on 13.10.2021 the physical counselling be held whose names have already been mentioned in the merit list. They will be required to pay the fee online upto 14.10.2021.
