THE DELHI High Court Tuesday sought Lieutenant Governor V K Saxena's response to AAP leader Jasmine Shah's plea against the L-G's decision asking CM Arvind Kejriwal to remove Shah from his post and restricting him from discharging his duties as vice-chairman of the Dialogue and Development Commission of Delhi (DDCD)

A single-judge bench of Justice Yashwant Varma asked advocate Santosh Kumar Tripathi, appearing for the L-G, director (planning) and sub-divisional magistrate (Civil Lines), to seek instructions from his clients on the question of whether the L-G has the jurisdiction to pass such an order order and the scope of the power the L-G can exercise.

Appearing for Shah, senior advocate Rajiv Nayar argued that the appointment of the DDCD V-C is made by a decision of the Delhi Cabinet and is "coterminous with the government".

The HC asked whether the L-G would have constitutional power to remove the DDCD V-C. Nayar responded that the L-G does not have the power, and that he couldn't have passed an inferim direction. The HC asked the parties how the DDCD V-C is appointed, and if any qualifications are required; it was informed that the position of V-C is honorary

When Nayar started to point towards Shah's accomplishments, court said, "You may be very accomplished... but what has been noted in L-G's order, also gets us thinking... Once you take up an honorary position whether you are obliged to give up another part of activities, while holding that post and office... can you continue or whether you should be permitted to continue"

The plea states that the decision against Shah bars him from using "any privileges and facilities connected with the office of V-C. DDCD, with immediate effect". The plea challenges four orders is-

IN THE first admission in court of violence against Shraddha Walkar, her live-in partner Aaftab Poonawala told a Delhi court on Tuesday that he hit her because she "provoked" him.

During the hearing. Metropolitan Magistrate Aviral Shukla asked Poonawala if he was mistreated during questioning or had any issues. "Poonawala told the court that he had no issues and that he was fully cooperating with the investigation. He also told the judge that he was provoked, because of which he hit (her)," Advocate Abinash Kumar, Poonawala's legal aid counsel. told The Indian Express.

Poonawala was produced before the court via video conferencing, and the hearing took place before the designated time, keeping in consideration his safety, said his lawyer. As a result, the media was not privy to the hearing.

The court sent him to four more days of police custody in connection with the case.

Poonawala (28) has been accused of allegedly killing 27-yearold Walkar on May 18, chopping her body into more than 30 parts, and disposing of the parts over two-three months.

#### MINOR'S RAPE CASE

### Bail pleas of two accused rejected

SHIMLA, NOVEMBER 22

wl

The HP High Court has rejected the bail applications of two persons accused of raping a 14-year-old girl.

The court observed, "Mere delay in lodging an FIR will not help the petitioners in their prayer for bail. Keeping in view the age of the victim and she having been allegedly put into fear of life, the delay in lodging an FIR can be said to be explainable during trial."

Satyen Justice observed, "It can't be said that there are no prima facie or reasonable grounds to believe that the accused have not committed the offence. The accusations against the petitioners are of serious and grave nature. The victim is of young age and if the petitioners are released on bail the possibility of them trying to influence the victim and other material witnesses can't be ruled out." Rejecting the bail pleas, the court said, "The offences alleged against the petitioners undoubtedly are of serious and heinous nature." - OC

PIL raised concern over paragliders' safety after 12-yr-old's death

The High Court has directed the state authorities to produce records of paragliding of the past five years.

It directed the authorities to consider suggestions given for the security and safety of paragliders and file a response by the next date of hearing. It listed the matter further hearing on December 16.

During the course of hearing, officers informed the court about the steps taken in this regard. After interacting with government officers, a Division Bench comprising Justice Tarlok Singh Chauhan and Justice Virender Singh observed, "We find the explanation offered by the state to be not only plausible but also sustainable that the provisions of the National

Aero Sports Policy (NASP) Act 2022 could not have been incorporated in the Himachal Pradesh Aero Sports Rules, 2022 as the rules were formulated and had come into force prior to the publication of the draft NASP Act 2022.

Amit Kashyap, Director,

Tourism and Civil Aviation, informed the court that these rules were being re-looked into. As far as possible, the rules would be brought in consonance with the provisions of the draft NASP Act.

On this, the court observed, "We have noticed that though the rules came into force with effect from April 20, 2022, the state did not constitute committees in terms of the rules."

Vijay Kumar, Special Secretary, Tourism, assured the court that a committee would be functional within a month from today. "The Tourism Department is exploring the possibility of providing various tracking systems for pilots, who may unfortunately meet with an accident or go missing," he said.

The court was informed that the department would also develop a mobile phone application, which besides ensuring that no pilot was overburdened would also ensure that equipment were not used eyond their life span.

The court passed the order on a PIL regarding the death of a 12-year-old at a paragliding site in the state on December 21, 2021.

## Four days on, Shimla trekker still not traced

KULLU, NOVEMBER 22

Even after an intensive search operation by the teams of Atal Bihari Vajpayee Institute of Mountaineering and Allied Sports (ABVIMAS), Adventure Tour Operator Association (ATOA), Kullu-Manali, police and administration, the whereabouts of trekker Ashutosh were not known even after four days.

Ashutosh from Shimla was hit by an avalanche at 17,490 ft-high Friendship Peak near Manali on Saturday

Negi said a team having 10 personnel equipped with a drone reached the avalanche spot and conducted recce and imaging through the drone.

However, nothing fruitful was discovered. He said the team would return today and visuals of the drone would be analyzed to find any clue about the missing trekker. He said all efforts were being made as the area would soon witness snow accumulation.

ATOA general secretary Praveen Sood said a team had been camping towards the Lahaul side of the peak as the avalanche occurred on both sides. The search operation was still underway. - OC

### Cold intensifies, vehicles not allowed beyond Kothi

KULLU, NOVEMBER 22

The NGT barrier at Gulaba will be shifted to Kothi and no vehicle will be allowed towards the Rohtang Pass beyond Kothi till further orders.

Kullu DC today issued orders under Section 115 of the Motor Vehicles Act 1988. The SDO, Manali, has reported that the road from Kothi to Marhi is not suitable for vehicmovement due extreme cold weather.

The DC said as per the report received from the Commanding Officer, 70 Road Construction Company,

view of the bad weather following intermittent snowfall, extremely low temperature and slippery road conditions, the road from Kothi to Rohtang has been closed for movement of vehicles.

The road is covered with frost in many places. The DC has passed these orders in view of public safety.

Generally, the Rohtang Pass is officially closed for traffic after November 15 but at times the vehicles ply up to there if there is no accumulation of snow and the road is cleared by the BRO. - OC






