## 53(18) Ordinance of Admission Committee.

The Ordinance of Admission Committee was approved by the Executive Council long back and it needed to be amended by incorporating the following:

- 6. Director, IQAC
- 7. Director, CDOE
- 8. Director, UCC
- Four members (instead of existing two members to be nominated by the Academic Council from amongst its own members for a term of two years.
- 10. Clause (g) may be amended as follows:
  - VII. Colleges/ Institutions maintained by the University.
  - VIII. Govt. Colleges other than the Colleges of Education
  - IX. Professional Colleges including Colleges of Education
  - X. Govt. aided Colleges other than the Colleges of Education
  - Non-Govt. SFS degree Colleges.

The above proposal was considered and approved by the Vice-Chancellor in anticipation of the approval of the Academic Council and the revised Ordinance for Admission Committee was notified.

The Vice-Chancellor ordered to place the same before the Academic Council for ratification.

The Academic Council vide Reso. No. 50 in its meeting held on 15.07.2023considered the above and passed the following resolution:

RESOLVED TO RATIFY THE ACTION TAKEN BY THE VICE-CHANCELLOR WITH THE STIPULATION THAT THE PROFESSIONAL COLLEGES BE SEPARATED FROM B.ED COLLEGES AND THEREFORE, THE MODIFIED INCORPORATION IN THE ORDINANCE WOULD BE AS FOLLOWS:

- 1. Director, IQAC
- 2. Director, CDOE
- 3. Director, UCC
- Four members (instead of existing two members to be nominated by the Academic Council from amongst its own members for a term of two years.
- 5. Clause (g) may be amended as follows:
  - Colleges/ Institutions maintained by the University.
  - II. Govt. Colleges other than the Colleges of Education
  - III. Professional Colleges
  - IV. Govt. aided Colleges other than the Colleges of Education
  - V. Non-Govt. SFS degree Colleges
  - VI. Colleges of Education
