It is hereby notified that Schedule of Submission of Registration Return-cum-Examination Form (Particulars in the R.R should be as per documents of the Students) as per following schedule:-

1.	Online submission of Registration Return-cum-Examination forms and generating challan for deposing fees without late fee in respect of Ph.D. Course work (Regular Course)	Upto 25.04.2024
2.	Submission of Hard Copy of the Registration Return alongwith required certificats/documents for checking of Eligibility and Migration Certificates	Upto 02.05.2024

Further, if any department fails to submit the documents/certificates along with the hardcopy of RR, the late fee as under will be charged as per prescribed schedule:-

(a) For the 1-30 days late after the expiry of normal due date: Rs. 500/- per student.

(b) For the 31-45 days late after the expiry of normal due date: Rs. 1000/- per student

(c) For the 46-60 days late after the expiry of normal due date: Rs. 2000/- per student

For one week before commencement of examinations and after that no request will be considered in any circumstances: Rs. 3000/- per student and permission of the Vice-Chancellor. Provided that in case a candidate is not able to submit the migration certificate while sending registration return, the migration of such candidates may be forwarded in original to the Registration & Scholarship Branch as per the schedule given below along with late fees mentioned against each.

Schedule of receiving of Migration Certificate:-

Up to 31.05.2024	With late fee of Rs. 500/-
Up to 30.06.2024	With late fee of Rs. 1000/-
Up to 31.07.2024	With late fee of Rs. 2000/-
