The candidates seeking admission to Ph.D. Programmes under Supernumerary Seats mentioned under Clause — 6.5 of Ph.D. Ordinance be exempted from entrance test provided that they are otherwise eligible and subject to availability of Supervisors.

2. Note 2 of the Clause 6.5. of the Ph.D. Ordinance be amended as under from the session 2019-20:
