The paper should not be plagiarized (same will be checked) and free from grammatical, spelling and other errors. The copy right form is enclosed herewith.

All the footnotes should be numbered serially and be placed on the bottom of the page. The designation and address of the author should be mentioned on the bottom of first page preceding the footnotes. References should be given in the last of the research paper.
