The Committee discussed the cases in detail and the following decisions were taken unanimously:-

1. Committee considered the issue in respect of Supernumerary Seats and resolved that students who have already opted the Choice of Supernumerary seats while filling their centralized online applications but could not separately apply on the M.D. University portal designated for the supernumerary seats be allowed to participate in the Counseling for such seats after payment of Rs. 600/- provided that the seats are available after considering those candidates who had already applied on M.D.U portal for supernumerary seats in the category in respective Departments.

2. The recommendations of the departmental committees of Dept of Statistics, Sanskrit, Defence & Strategic Studies and Dept of Visual Arts were considered and resolved to approve the same for enhancement of seats. The Counseling for the increased/vacant seats will be carried out on the part of respective Departments by displaying on the University website/notice board. The admissions will be made as per merit and reservation policy among the candidates who have already applied online and are in the waiting list.

3. The requests of two candidates, namely Ms Dimple and Ms Nitika forwarded by the Registrar for consideration of increasing seats in 5-Year Integrated Course in the Dept of English were also considered and it was resolved to seek comments from the Head, Dept of English over the contents and requests.
