MINUTES OF THE MEETING OF GRIEVANCES COMMITTEE HELD ON 07.09.2019 11:00 AM

The Committee Meeting with regard to representations of some students who want to take admission in languages courses run by the Department of English & Foreign Languages alongwith the admission case of M.A. (Economics) 5 year program discussed in detail and recommended as under:-

- 1. The Eligibility conditions for the courses being run by the Department of English and Foreign Languages alongwith the Department of Music which have already been mentioned in Prospectus (Non-Centralized) will remain same.
- 2. The Committee considered the request of Ms. Nisa D/o. Sh. Mukesh Kumar Mr. Vaibhav Kumar S/o Sh. Dharampal who wanted to take admission in M.A. (Economics) 5 year program. Both students were present for admission on 31.08.2019 but the counseling could not be conducted due to the grievance regarding the status of one vacant seat because due to technical problem the admission Committee could not decide whether the seat should be filled in SC category or Haryana Open General.

After detailed deliberations, the Committee recommends that one special seat be created for SC candidate namely Mr. Vaibhav Kumar S/o Sh. Dharmapal for the admission in M.A. (Economics) 5 year program and the admission of Ms. Nisa D/o Sh. Mukesh Kumar be granted in M.A.(Economics) 5 year program against vacant seat of Haryana Open General category as department had notified the seat for Haryana Open General.
