NOTIFICATION

This is in furtherance to our Endorsement No. DR/GA/CE/2020/2657-2756 dated 03.07.2020 whereby extension of closure of Maharshi Dayanand University and Colleges under its jurisdiction upto 31.07.2020 was notified. In view of the directions issued by the Ministry of Home Affairs, Govt. of India and the communication made by the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Haryana State Disaster Management Committee, Government of Haryana vide Memo. No. DMC-SPO-2020/9033 dated 30.07.2020, the following instructions and the other steps/measures already being taken/adopted by the University in light of the University's earlier notifications will remain actively enforce in the University till 31-08-2020:

- 1. The administrative and ministerial staff in the University will be coming as per the usual protocol, except the personnel from containment zone, if any. All will maintain social distancing as per protocol and will strictly follow the national directives for COVID-19 management.
- 2. There shall be no classroom teaching and physical public dealing during this period. No student shall attend the University Teaching Departments/MDU-CPAS till further guidelines in this regard.
- 3. Faculty members including resource persons will deliver online classes from the Department of the University/CPAS as per Time-Table of the concerned department/CPAS and utilize this period for various academic activities as assigned by the University from time to time with all precautionary measures as mentioned in the guidelines issued by MHA.
- 4. Aarogya Setu App enables easy identification of potential risk of infection and, therefore, it may be ensured by Heads of UTDs and Heads of various branches/offices of the University that Aarogya Setu App is installed by all the employees to fight against COVID-19.
