The Committee considered the requests received from the various students of intermediate semesters who have shown inability to pay the fees/dues in one lot due to financial crunch in the family which might have arisen due to COVID-19 Pandemic and recommended as under:

The students who have been unable to pay full fee due to situation arisen out of COVID-19 Pandemic by 14th August 2020 may be allowed to pay their fee of intermediate classes in two equal installments. The 1st installment be deposited upto 20th August, 2020 and the 2nd installment be deposited by 31st October, 2020. If such students do not deposit the 2nd installment by 31st October 2020, their admission will stand cancelled automatically.
