## The following decision were taken:

- 1. The minutes of the previous meeting of the CBCS Board held on 12.03.2020 be confirmed.
- Considered the recommendations of the Committee constituted by the Vice-Chancellor that
  the Ordinance of B.A/B.Sc./B.Com under CBCS from the session 2020-21 be prescribed as
  (Annexure 1 pages 1 to 31) already circulated.

## Resolved that:

- (i) The Ordinance be prescribed as Common Draft Ordinance/Guidelines and Scheme of Examination Under Choice Based Credit System (CBCS) for Undergraduate Pass Programs (B.A., B.Com. and B.Sc.).

  When briefed, the CBCS Board appreciated the efforts made by the Committee comprising Prof. Nina Singh, Dean, Academic Affairs, Prof. A.S. Maan, Dean, Faculty of Physical Sciences, Prof. Gulshan Lal Taneja and Dr. B.S. Sindhu, Controller of Examinations for preparing the Common Ordinance for CBCS. The contribution of all faculty members in this endeavour was duly acknowledged.
- (ii) The Ordinance be printed with 'Draft Ordinance' watermark and uploaded on the University website for feedback/suggestions from stakeholders, including teachers, students, researchers and those involved in the field to be sent latest by September 15, 2020. Based on the comments received and wider consultations with the experts of the field, the scheme of examination and syllabus shall thereafter be passed in the respective Board of Studies. Finally the Ordinance, Scheme of Examination will be placed before the Academic Council for approval.

Resolved further that the following may be inserted as Clause (iv) in the Ordinance: "it is mandatory for the student to fill up examination form alongwith required fee otherwise he/she will not be promoted to the next semester and he has to seek re-admission in the relevant semester".

Also resolved that the CBCS be introduced in BBA/BCA/5 Year Integrated/Hons. courses and remaining UG Courses and a Committee may be constituted by the Vice-Chancellor to design it.

3. Considered the recommendations of the Committee constituted by the Vice-Chancellor with regard to showing the marks/grade in the DMC of students for UG/PG Courses from the session 2020-21 as under: The Committee deliberated upon the issue at length and resolved that from the session 2020-21 onwards, the Detailed Marks Card for UG and PG Programmes should indicate percentage of marks calculated solely on the basis of marks secured by a candidate alongwith SGPA/CGPA earned by the candidate. Further, the conversion formula need not be mentioned in the Detailed Marks Card (Annexure II page 32) (already circulated)

Resolved that the following be approved and recommended to the Academic Council for approval:

The Detailed Marks Card for UG and PG Programmes from the session 2020-21 onwards should indicate percentage of marks calculated solely on the basis of marks secured by a candidate alongwith SGPA/CGPA earned by the candidate.

4. Considered the recommendations of the Committee constituted by the Dean, Academic Affairs held on 11.11.2019 regarding introduction of module for Consumer Affairs at UG Level as an elective course may be prescribed as (Annexure III pages 33 to 36).

Resolved to refer it back to a Committee recommended as under for consideration of the matter on the format of other Elective Courses.
