Guidelines for opening of University in Physical Mode

In continuation to this office Endst. bearing no. ACS-III/2021/15736-935 dated 18.11.2021 regarding decision taken by the University to open the University in Physical Mode. The following has been further decided by the University:-

- 1. Keeping in view the difficulty in implementation of the guidelines regarding full vaccination in respect of students below 18 years, the classes of first semester of all the Programs for which eligibility condition is 10+2 will be conducted through online mode till further orders.
- 2. Regarding hostel accommodation, Head of each Department will make merit of students mentioning status of vaccination i.e. single/double dose. Seat will be kept reserved for a student who has been administered single dose of vaccination, but falls otherwise in merit as per hostel rules. However, he/she will be allowed accommodation only after he/she is vaccinated with second dose.
- 3. The Departments are allowed to teach upto 40% of each course through online mode.
- 4. As the hostels are being provided from 01.12.2021 to 31.07.2022 for the academic session 2021-22, therefore the stay of the students for this academic session will be for 8 months and hence the annual charges as applicable for hostel accommodation will be charged proportionately i.e. multiplying the annual charges by 2/3.
- 5. Guidelines/Instructions already issued by the University vide Endst. bearing no. ACS-III/2021/15736-935 dated 18.11.2021 other than above should be followed as such except the guideline at sr. No. 2 of earlier notification, which is modified as follows:

Only those students will be permitted to attend the classes physically who have been fully/partially vaccinated.
