**Sub: Reso. No. 11 of the meeting of the Faculty of Management Sciences & Commerce held on 08.03.2021 regarding minimum number of students for offering any specialization in 2 year MBA (General) programme.**

Sir/Madam,

I am directed to inform you that the Faculty of Management Sciences & Commerce vide Reso. No. 11 of its meeting held on 08.03.2021 resolved as under:-

11. "Considered the recommendations of the PG Board of Studies in Management Studies vide Reso. No. 2 in its meeting held on 12.12.2020 that the condition of minimum number of students for offering any specialization in 2 year MBA (General) programme may be allowed as per past practice for the current session as IMSAR is introducing new specialization of Business Analytics in MBA (Hons.) and MBA (Business Economics) and Public Policy in MBA (Business Economics).

**THE FACULTY NOTED THAT THE ACADEMIC COUNCIL VIDE RESO. NO. 18 OF ITS MEETING HELD ON 24.10.2020 HAD ALREADY RESOLVED THAT MINIMUM REQUIREMENT OF 10 STUDENTS FOR EACH SPECIALIZATION IN 2 - YEAR MBA (GENERAL ) INSTEAD OF 15 STUDENTS.**

**IN VIEW OF THE ABOVE, THE FACULTY RESOLVED THAT THE ABOVE DECISION OF ACADEMIC COUNCIL BE IMPLEMENTED FROM THE NEXT SESSION. IN VIEW OF COVID-19 PANDEMIC, FOR THE CURRENT SESSION , 5 STUDENTS MAY BE ALLOWED TO OFFER ANY SPECIALIZATION IN GROUP 'A' AND GROUP 'B' IN 2 YEARS MBA(GENERAL)."**

The matter has been considered by the Vice-Chancellor and he has ordered as under:-

1. Faculty of Management Sciences & Commerce in its meeting held on 08.03.2021 have violated the Reso. No. 18 of Academic Council dated 24.01.2020 while considering its agenda item 11.
2. The HODs/Directors of the departments/ Institutes who have made admissions in 2020-21 with less than 10 students for each specialization by ignoring AC resolution be issued advice to be careful in future.
3. Keeping in view the interests of already admitted students, the provision of 5 students be allowed for the current session.

In view of the above, you are requested kindly to intimate urgently which College/Institution allowed 5 students to offer any specialization in group 'A' & group 'B' in 2 year MBA (General) during the session 2020-21 so that the concerned Directors/HODs may be issued advice accordingly.
