1. Online Admissions may be made by the Engineering/Management and Law Colleges (as  
the case may be) strictly as per merit and eligibility conditions prescribed by the  
University. Reservation Policy of the State Government may be followed. A copy of  
Memo No. 40395 DHE-190005/97/2020-UNP (STATE)-DHE dated 19.04.2021 received  
from Director General Higher Education, Haryana, Panchkula regarding EWS  
candidates@ 10% is to be given in both State Quota seats under Central Government  
Policy separately and the University has decided to implement the same from the session  
2021-22.
2. Arrangements may be made by the colleges at its own level for collecting the fee from the  
candidates.
3. Online/offline classes may be conducted by the colleges as per instructions of the State  
Govt. in the matter from time to time.

Eligibility conditions for admission to various courses and Admission Procedure & Regulation  
are available on the University website.

It will be the entire responsibility of the Principal/Director of the concerned College/Institute to  
ensure that no wrong admission is made by the College/Institute.

It is further made clear that wrong admission(s), if any, made by the College/Institute shall not be  
accepted/regularized by the University and the expenditure incurred on litigation in such cases by the
