The Committee deliberated upon the issue at length and considered the following:-

#### 1. Classrooms Teaching

In the beginning of semester students be engaged for teaching/activities if teachers is not available. Presently one unit of 80 students has been formed for Foundation Open Elective Courses. If the number of students in a particular paper are on higher side the classes may be conducted through online mode.

### 2. Mentor /Mentee group

1-2 hours per week be kept for mentor/mentee group in which the problems of students be discussed and resolved. As per past practice, for this purpose Whatsapp group be maintained.

#### 3. Engagement of Faculties

If the regular teachers are not available in the Department, Distinguished Visiting Faculty, Honorary Faculty, Visiting Faculty, Adjunct Faculty and Floating Faculty may be identified as per the rules already approved by the University for the purpose from time to time so that teaching may not suffer. Extension Lecture/Seminar may also be organised by ' Departments/Institutes. Budget for the purpose has already been provided by the University.

#### 4. Academic Activity Plan

Weekly/Fortnightly Academic Activity may be organised by the Departments/Institutes so that the students may have the knowledge of extra curricular activities besides teaching.

- 5. Concerned Dean of the Faculties may convene the meeting of the HODs to ensure the classes regularly. Concerned teacher should also inform to the HOD in time if the class is not being held due to any reason. Whatsapp group be maintained to inform the students in the matter. The students may be asked to study in the library if the class is not being conducted or another teacher may be deputed by the HOD for holding the classes.
- **6.** To maintain discipline and in the academic interest the classes be held regularly and attendance be followed strictly.
