About the University

About Law Faculty

The Department of Law was established in the University in 1978. The Maharshi Dayanand University was the first University in the country to introduce the Five Year Integrated Law Course and has been running it successfully since 1983.

Theme of the Seminar

A move that gained momentum in the closing years of 20th century was the need to establish public policies seen as ‘policy sciences of democracy’ that address human rights–human dignity, self-determination, empowerment-economic, cultural, social, and political and removal of powerlessness. Needless to say human rights are interdependent, comprehensive, and therefore indivisible. These call for both affirmative and transformative actions.

The primary objective of the seminar is to examine the nature of the shift to the human rights framework of reference in the context of disability. Through this platform, the Department will make efforts to explain the relevance of Human Rights values and doctrine to disability. It asserts that the core problem in the field of disability is the relative invisibility of persons with disabilities, both in society and under the existing international human rights instruments. The main human rights challenge is accommodating the difference of disability and making people with disabilities visible within the treaty system. People with disabilities must be afforded freedom, but also the means to take advantage of it. This can be done by providing relevant social supports and in particular, by respecting economic, social and cultural rights.

‘Human Rights of Persons with Disabilities in India: Issues and Challenges’ will act as a platform for all academicians, intellectuals, students, scholars, citizens, and people from all walks of life to come together and discuss various issues, ideas, facets of this fascinating theme. This is a small initiative from our side to make world a better place to live in. Contribute and be a part of the change.
