It shall be the responsibility of Organisers of event to ensure that only fully vaccinated persons attend the events organized by them.
III. In all the public offices and facilities, only fully vaccinated persons are allowed to enter w.e.f. 01.01.2021.

g. Coaching Institutions, Libraries and Training Institutes (whether Govt. or Pvt.) are allowed to open with strict adherence of requisite social distancing norms, Covid appropriate behavioral norms guidelines as indicated in the SOPs released by Ministry of Health and Family Welfare, GOI and regular sanitization of premises.
h. Industrial 'Training Institutes (ITls) are allowed to open for students with $100 \%$ attendance with strict atherence of repulsite social distancing norms, regular sanitization of the premises, Covid appropriate behnvileral norms and gudelines as indicated in the SOP's relensed loy Ministry of Ilealth and Fimmily Welfare, GOI. Department of Skill Development \& Industrinl Trainhng, Inaryann will release guidelines for implementation of these orders immediately.
i. All Shops and Malls are allowed to open with adherence to repuisite social distancing norms, regular sanilization and Covid-15 approprinte behavioral norms.
j. Swimming Pools are allowed to open after adopting repuisite social distancing norms, regular samilization and Covid approprinte behnvioral norms. All swimmers/practitioners/eligible visitors and staff to preferably get vaecinated wilh both doses of Covid-19 varecine.
k. Sports Complexes, Stadia are permitted to open for sports activities including for outdoor sports activities exeep contact sports (Spectators will not be allowed). Sports Authorities shall ensure atherence of repuisite social distancing norms, regular sanitization of the premises and Covid-19 appropriate behavioral norms.

1. Religious places are allowed to open with 50 persons at one time with the condition that they shall follow requisite social distancing norms, regular samitization and Covid-19 appropriate behavioral norms.
m. Corporate Offices are permitted to open wilh full attendance sulbject to strict observance of social distancing, Covid-19 appropriate behavioral norms and regular sanitization.
n. All productions units, Establishments, Industries are permitted to function. However they shall strietly adhere to COVID-19 :appropriate and preseribed guidelines, behavioral norms and Social distancing.
o. "No Mask-No Sevice" will be strictly olserved in the District. People with face cover/mask only be allowed to board public/private transport and enter any other government and private establishment for availing any service/goods.
p. There will be continuous focus on the five fold strategy for effective management of Covid-19 i.c. Test-Trace-Track-Vaccination and Adherence of Covid-19 appropriate behaviour.
