Item No.-1 To review the eligibility condition for admission in Ph.d in Management against supernumerary quota.

It was resolved that the exiting eligibility condition for admission in Ph.d in Management be proposed as under:-

Existing Eligibility	Proposed Eligibility
One supervumerary seat in each Department for the Corporate Professionals working atleast at Deputy General Manager (DGM)/General Manager Level (or equivalent thereof) or Deputy Director/Director (or equivalent thereof) for minimum ten years at Corporate level with the condition that the Company's turnover should be at least 300 crores per annum.	One supervumerary seat in each Department for the Corporate Professionals and having 10 years minimum experience with the condition that the Company's turnover should be at least 300 crores per annum.

Item No.-2 To incorporate the changes/modifications in the existing Scheme and syllabus of 2 Year MBA (Hons./B.E.) in view of the new specialization offered by IMSAR.

It was resolved that Director may be authorized to constitute the committees to change/modify in the existing Scheme and syllabus of 2 Year MBA (Hons./B.E.) as offered by IMSAR.

The meeting ended with a vote of thanks to the Chair.


