- For colleges the college shall adopt the process of full fee collection if the student desires to freeze the seat for token money of Rs. 5000/- . if the student desires to participate in the next round of counselling as per their own mechanism keeping in view the refund provision of the fee as per the clause 11 (Page no. 9, section-I) of the prospectus.
