UNDER ANY OTHER ITEM, THE COMMITTEE RESOLVED THAT IN VIEW OF THE GRIEVIENCE OF SOME APPLICANT OF BC-A/ BC-B CATEGORY IN COMMERCE DEPARTMENT, WHO WERE ADMITTED AND LATER ON THEIR ADMISSIONS WERE CANCELLED, THEY MAY BE CONSIDERED FOR ADMISSION IN 4TH COUNSELLING AS PER MERIT, IF SEATS ARE VACANT, IRRESPECTIVE OF DATE OF ISSUEANCE OF INCOME CERTIFICATE BUT PRIOR TO DATE OF 4TH COUNSELLING. OTHER SIMILAR CANDIDATES MAY ALSO BE CONSIDERED AS PER MERIT AGAINST VACANT SEATS, IF ANY. The Executive Council considered the action taken by the Vice-Chancellor referred to as above and resolved as under:

35. To consider the recommendations of the Academic Council made vide Resolution No. 51, in its meeting held on 19.10.2022 with regard to UGC guidelines for pursuing two Academic Programs simultaneously.

The University received a letter dated 13.04.2022 from the UGC, New Delhi concerning guidelines for pursuing two Academic Programs simultaneously and for implementation of the same of in view of NEP 2020. On the recommendations of a committee, the matter was referred to the Academic Council for amendment in the relevant Ordinance. The Academic Council vide Resolution No. 51 of its meeting held on 19.10.2022 resolved to approve the proposal in principle and for constitution of a committee for studying the feasibility of offering two full time academic programs in physical mode. The committee so constituted recommended to place the guidelines dated 13-4-2023 for pursuing two academic programs simultaneously and amendment in clause-13 of the Ordinance for General Rules of Examinations 'In Principle' before the EC.

The Executive Council considered the recommendations of the Academic Council made vide Resolution No. 51 dated 19.10.2022 as above and resolved as under:

RESOLVED TO APPROVE THE RECOMMENDATIONS OF ACADEMIC COUNCIL MENTIONED AS ABOVE.

36. To ratify the action taken by the Vice-Chancellor in slight rectification in the Executive Council Reso. No. 59 of the meeting held on 29.09.2022 to round up to the digits to next multiple of 10 with reference to 10% increase in Development Fee, or any kind of fee in anticipation of approval of the Executive Council as the prospectus was to be released prior to the date of the meeting of the Executive Council.

The Executive Council vide Reso. No. 59 in its meeting of 29.09.2022 revised various fee structures out of which migration fee was to be implemented with immediate effect and fee related to examinations, R & S branch and miscellaneous fee were to be implemented with effect from session 2023-24. It also resolved to increase the fees related to examinations branches, R & S branch and miscellaneous fee by 10% every year. Some essentially required modifications were further made in the decisions. As the amount to be charged as fee was
