लापता हो गई। बच्ची से दुष्कर्म करने के बाद उसे गांव के बाहर खेत में फेंक दिया गया।

मूलरूप से उत्तर प्रदेश निवासी बच्ची के परिजनों ने बताया कि उनका परिवार करीव डेढ़ साल से मुरथल थाना क्षेत्र के गांव में रहता है। उनकी 6 साल की बच्ची बुधवार रात करीब आठ बजे घर के बाहर खेल रही थी। इसके बाद वह अचानक से लापता हो गई। परिजनों ने उसकी काफी तलाश की, लेकिन कोई पता नहीं लग सका। उन्होंने मामले से पुलिस को भी अवगत कराया। सुबह परिजनों को बच्ची गांव के बाहर खेत में वेसघ अवस्था में पड़ी मिली। बच्ची की हालत काफी विगड़ी हुई थी। परिजनों ने इसकी सूचना पुलिस को देकर बच्ची को नागरिक अस्पताल में पहुंचाया। जहां पर बच्ची को प्राथमिक उपचार दिया गया। होश में आने के बाद भी बच्ची बरी तरह सहमी हुई थी। उसे पर उसे उपचार दिया जा रहा है। पलिस ने मामले में बुधवार शाम को पॉक्सो एक्ट समेत अन्य धाराओं में मुकदमा दर्ज कर लिया है। पुलिस टीम मामले में गहनता से जांच कर रही है।
