61. Consideration of the matter with regard to Enhancement of the Entertainment Allowance from Rs. 2000/- for the office of DCDC & Librarian and to bring them at par with the office of Registrar/Finance Officer/COE/Director C.D.O.E. (Center for Distance and online Education) and Dean Academic Affairs.

The office received the requests from the DCDC and Librarian regarding enhancement of the Entertainment Allowance. After consideration the matter, Vice-Chancellor Constituted a Committee for the purpose. The meeting of the committee under the Chairmanship of Dean Academic Affairs was held on

10.08.2022 and the Committee discussed the matter with regard to revision/increase of rates of the Entertainment Allowance as approved in the Executive Council meeting vide Reso No.40 held on 13.08.2017. As per request of DCDC on 25.03.2022 and Librarian on 28.03.2022 with regard to cater large number of visitors not only from affiliated colleges but also comprise of various faculty members of different committees and also so many kind official guests i.e. National and International Publishers, Vendors, Booksellers, various faculty members and other HoD(s) for discussion relating to various kinds of new arrivals of books, journals and current research, Awareness and Orientation Programmes, etc.

Accordingly, the Committee recommended that the rules for Entertainment Allowance in case of DCDC and Librarian may be amended as under:
