## Subject: Implementation of Academic Bank of Credits (ABC) at Maharshi Dayanand University, Rohtak

This is to submit that the university has entrusted the undersigned the responsibility as Nodal Officer, Academic Bank of Credits (ABC) vide office Endst. No. ET-2/2023/M-85/433-503 dated 13.01.2023 (F/'A').

PUC received from Prof. Manish R. Joshi Secretary, University Grants Commission may kindly be perused vide which it has been intimated that Govt. of India, under the New Education Policy, 2020 has launched the Academic Bank of Credits (ABC) scheme. Accordingly, the University Grants Commission, with the concurrence of Ministry of Education has notified "The University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) regulations, 2021 in the Gazette of India on 28th July 2021. Further to enhance the reach of the programme, it is requested that all Academic Institutions will do the following under intimation to UGC:

- i. Register your Institution on NAD/ABC portal (https://nad.digilocaker.govt.in/)
- Designate Nodal Officer and set up a dedicated NAD/ABC Cell for implementation of NAD/ABC scheme and reflect their details i.e. (Name, Designation, Mobile number and Email id) on respective Institution's website.
- iii. Advise the students to register on ABC portal though <a href="https://www.abc.go.in/">https://www.abc.go.in/</a>.
- iv. ABC ID should be made a mandatory field in the admission forms, examinations forms or if possible on Student's I-card also.
- v. Display the poster & templates and placing them on the canteen, library, notice board and around the playground or the place where there is maximum movement of Students.
- vi. Organizing the seminar/workshop for information and publicity about ABC in Campus as well as respective affiliated colleges.

To attain the objectives of ABC, you are requested to on-board (if not on boarded) with ABC and upload academic data with students' earned credit obtained during or after the academic year 2021-22 alongwith students' ABC ID.

In this regard, it is submitted that work of Academic Bank of Credit was earlier assigned to Mr. Sameer Dahiya, System Analyst, EDP Cell and Mr. Yashpal, System Analyst, UCC. As a Nodal Officer (ABC), a meeting of the following was held on 22.02.2023:

- 1. Dr. Nasib Singh Gill, Nodal Officer, ABC
- 2. Mr. Sameer Dahiya, System Analyst, EDP Cell
- 3. Mr. Yashpal Hooda, System Analyst, UCC

and concerned CDOE officials dealing with ABCs were also invited to look into the current status of ABC and future action plan.

After detailed deliberations and in the light of the directions contained in the PUC from UGC for implementation of Academic Bank of Credits (ABC) in the University, this is to submit that the following steps have already been taken up:

- MDU has already registered on NAD as well as ABC.
- 2. The nodal officer for NAD/ABC is designated and the creation of NAD/ABC Cell is pending, but the existing EDP Cell under supervision of Sh. Sameer Dahiya, SA, who is already looking after NAD affairs may be allowed to transact the business of NAD/ABC Cell as mandated by UGC.
- 3. The Centre for Distance and Online Education has already started creation/registration of CDOE students for ABC ID. The same process needs to be followed by the R&S Branch also for creation/registration of ABC IDs for regular admitted students. Once the ABC registration/creation of ABC IDs is done by the University, then the same may be circulated to the students through colleges/departments.
- 4. Points nos. (iv) to (vi): Once the ABC IDs are created, then these steps may be taken up.

Keeping in view, the position explained above, the Vice-Chancellor is requested to approve the followings:

- 1. Allowing ABC Id, Adhaar Id, Mobile to be mandatory for students in the Online Admission from session 2023-24.
- 2. Allowing and directing the Colleges/Institutes affiliated to MDU for making Student ABC Id, Adhaar Id, Mobile mandatory for Admissions from 2023-24.
- 3. Allowing and directing the R&S branch to arrange to create the ABC IDs for regular students too as done by CDOE for the students enrolled in the session 2022-23.
- 4. Allowing the FDC/CRSIS&EC/DLC to conduct/organize Workshops for stakeholders to sensitize about ABC IDs
- 5. Allowing to publicise the ABC though University website, social media, electronic/print media, on students WhatsApp Groups or any other ways.
