- 3. Newly enlisted contractors/societies/suppliers/manufactures should bring with them proof of their enlistment in appropriate class.
- 4.The bidders would submit bid through e-tendering only on the website i.e. www.etenders.hry.nic.in.

Under this process, the Pre-qualification/ Technical online bid Application as well as online Price Bid shall be invited at single stage under two covers i.e. PQQ/Technical & Commercial Envelope. Eligibility and qualification of the Applicant will be first examined based on the details submitted online under first cover (PQQ or Technical) with respect to eligibility and qualification criteria prescribed in this Tender document. The Price Bid under the second cover shall be opened for only those Applicants whose PQQ/ Technical Applications are responsive to eligibility and qualifications requirements as per Tender document.

- 1. The payment for e-Service Fee shall be made by eligible bidders online directly through Debit Cards & Internet Banking Accounts and the payment for EMD & Tender Fee can be made through online mode only.
- 2. Intending bidders will be mandatorily required to online sign-up (create user account) on the website https://haryanaeprocurement.gov.in to be eligible to participate in the e-Tender. <u>He/She</u> will be required to make online payment of EMD fee in due course of time. The intended bidder fails to pay EMD fee under the stipulated time frame shall not be allow to submit his / her bids for the respective event / Tenders.
- 3. The interested bidders must remit the funds at least T+1 working day (Transaction day + One working Day) in advance i.e. on or before (08.06.2023); and make payment via NET BANKING/RTGS /NEFT or OTC to the beneficiary account number specified under the online generated challan. ## **Important Note:**

- The Applicants/bidders have to complete 'Application / Bid Preparation & Submission' stage on scheduled time as mentioned above. If any Applicant / bidder failed to complete his / her aforesaid stage in the stipulated online time schedule for this stage, his / her Application/bid status will be considered as 'Applications / bids not submitted'.
- 2) Applicant/Bidder must confirm & check his/her Application/bid status after completion of his/her all activities for e-bidding.
- Applicant/Bidder can rework on his/her bids even after completion of 'Application/Bid Preparation & submission stage' (Application/Bidder Stage), subject to the condition that the rework must take place during the stipulated time frame of the Applicant/Bidder Stage.

#### **TERMS & CONDITIONS: -**

- 1. Bids from **original manufacturers** will be accepted.
- 2. Latest ISO certificates are mandatory for glassware & plasticware. The certificates must be enclosed with tender documents.
- 3. Five set of Price Lists must be enclosed with technical bid of tender documents.
- 4. Each manufacturer has to furnish an undertaking to the undersigned that the discount offered to M.D.University, Rohtak is the maximum & no Govt./Semi Govt. Institutions/Universities have been offered discount more than quoted one.
- 5. The manufacturer is required to furnish a certificate of his authorized distributor alongwith tender documents (OEM Authorization Certificate).
- 6. No advance payment will be made for the supplier.
- 7. PAN No. & GST No. must be enclosed with the tender documents.
- 8. All the disputes to any one will be subject to the jurisdiction at Rohtak (Haryana).
- **9.** The order will be placed after comparing the rates except **research items** (as benefits of the university). **Research items may be purchased on quality basis.**
- 10. The firm will be required to record following certificates in every bill:

  The rate is being charged as per prevailing price, as applicable to all Govt./Semi Govt. and other institutions. That the discount offered to the university is the maximum and they have not offered more discount to any Govt., Semi Govt. and other institutions.
- 11. The rate contract being established by the university should not be tagged with the rate contract established by the Govt. of Haryana as the requirements of the University Departments are quite different from those of Govt. of Haryana.
- 12. If the Haryana Govt. establish the rate contract with the same items on better terms and conditions for the year 2023-24 the same will also be applicable to M.D.University, Rohtak.
- 13. The supplied chemicals must be of fresh stock (not more than 06 months old).
- 14. The claimed purity/specifications should be followed. If the supplied chemicals are of low purity, company has to replace it at his own cost within stipulated period, otherwise it will be blacklisted.
- 15. The rate contract initially will be valid from one year i.e1<sup>st</sup>July, 2023 to 31<sup>st</sup>July, 2024 and may be extended for another one year i.e1<sup>st</sup> July, 2024 to 31<sup>st</sup> July, 2025 as per university rules on same terms and conditions.
- 16. The Earnest Money and Tender Fee will be considered through online mode only in favour of Finance Officer, M.D. University, Rohtak.
- 17. The supply will be made F.O.R. M.D.University, Rohtak & bill in duplicate must be submitted.

- 18. The order must be executed within 4-6 weeks after receipt of supply order.
- 19. Technical documents and Commercial bid/price must be submitted in sealed envelope along with tender documents.
- 20. MSME are exempted in tender fee & EMD only as per Haryana Govt. Policy.
- 21. The bidder must submit an Affidavit on non –judicial stamp paper duly attested 1<sup>st</sup> Class Magistrate/Notary Attest to the effect that they have not been debarred/blacklisted by any State Govt.,/Central Govt./PSU Department in India/Public or Private Institute (Annexure-1).
