- Every e-tender shall be accompanied by the Earnest Money 30,000/- (Fixed) and Rs.2000/- as tender fee and Rs.1180/- the e-service fee should be deposited through online mode only.
- 2. The e-tender received without earnest money or after the due date shall not be entertained except with the special approval of the competent authorities.
- 3. The e-tenders shall be opened in the office of HOD(Genetics), M.D. University, Rohtak on _____ at 11:00 a.m. by the Purchase Committee. The quotes or their authorized representatives are allowed to attend the meeting of the Tender Opening Committee at their own costs.
- 4. The goods shall be supplied by the Supplier within the time limit specified in the supply order. In case, the material is not supplied within the delivery period, the supplier shall be liable to pay the University the compensation amount equivalent to 1% (one percent) of the cost of material each day or such other amount as the CPC/Asstt.
