2. They will be on probation for a period of one year in the first instance w.e.f. the date they submit their joining report on promotional post. If during this period, their work and conduct is not found satisfactory, they will be reverted to their substantive post.
3. The other terms and conditions of their promotion in so far as they are not specified here, will be governed by the rules and regulations of the University as are framed/ made applicable from time to time.
