Sub.: Important Clarifications regarding forthcoming admissions for PG Programme, LLB (Hons) 3-Year and B.P.Ed programs in UTDs and MDU-CPAS during the session 2024-25

Sir/Madam

In terms of orders passed by competent authority, following points are brought to your kind notice for consideration for smooth conduct of counselling process:

- 1. In case of original DMC of the qualifying examinations is not available with the applicant, he /she may submit the down-loaded result from the Net, duly certified by the Head of the concerned College/Institute. However, he/she is required to submit the original DMC of the qualifying exam within next 07 (seven) days failing which his/her admission shall be treated as CANCELLED.
- In case of candidate who has inadvertently applied against AI Category seats but fullfills the conditions of being Haryana resident as per Appendix-A given in the prospectus, he/she may be considered against HOGC category on his/her request.
- 3. Clarification about Economically Weaker Section (EWS) seats:
  - (i) A candidate who has applied under EWS or Haryana EWS Category and is a bonafide resident of Haryana/Passed the qualifying Exam form Haryana, may be considered for the seats reserved for the Economically Weaker Section of Haryana, if otherwise eligible.
  - (ii) A candidate who has applied under EWS or Haryana EWS Category but is NOT a bonafide resident of Haryana and has not passed the qualifying exam from Haryana, should be considered for the seats reserved for

the Economically Weaker Section (EWS) under AI Category as per Central Govt. Policy, if otherwise eligible.

- (iii) All candidates satisfying the above condition (i) are also eligible to be considered against the seats reserved for the Economically Weaker Section (EWS) under Al Category as per Central Govt. Policy
- 4. In rest of case(s) of Change of Category of the students, the same may be allowed after 3<sup>rd</sup> Counselling. If the seat(s) remains vacant after 3<sup>rd</sup> Counselling in any category, the request(s) received from the students on the spot in the Department, if any, regarding the change of category may be considered and forwarded to UCC for the change of category after carefully verifying the relevant documents. After the change of category, the seats remaining vacant should be first filled category-wise as per merit of the entrance test on 4<sup>th</sup> Counselling and after that the seats still remaining vacant be converted to open category on the same date and to be filled up as per the guidelines available in the Prospectus for the session 2024-25.

You are requested to take appropriate action accordingly.
