Sir/Madam,

I am directed to inform you that a meeting under the Chairmanship of Vice-Chancellor was held on 13.05.2024 regarding Conduct of classes for the students admitted to Ph.D Course Work through entrance test. In the meeting, after detailed deliberation, it was unanimously resolved that:

- 1. All departments where the admissions have been made both out of JRF/NET as well as through entrance test shall ensure that the Classes for the students through entrance test are conducted in accordance with the minimum number of teaching days required as per norms stipulated in the Prospectus. The examinations for all the students in Ph.D. program will be conducted simultaneously only after fulfilment of the said condition. For this purpose, the department shall arrange classes during the summer vacations and complete the syllabi upto 31.07.2024.
- 2. The Course work examination in respect of all departments will be held in August 2024.
- 3. CRSIS E & C shall also conduct special classes for the students admitted through entrance test so as to complete the teaching of the paper of Research & Publication Ethics during the period upto 31.07.2024.

The above recommendations have been approved by the Vice-Chancellor and accordingly you are requested kindly to adhere to the above recommendations. This is, however, issued in supersession to earlier notification issued vide Endst. No. AC-6/24/6274-340 dated 06.05.2024.
