Apart from this, stunting of physical growth and failure of animals to show estrus signs on time can be the main symptoms of its deficiency. In many animals, its deficiency causes haemoglobinuria condition in high yielders.

Manganese: With its deficiency, the animal becomes weak. In addition, older animals may experience temporary infertility due to its deficiency.

Zinc: Due to lack of zinc in diet, the skin of animals becomes thick and leads to parakeratosis of the skin. With its deficiency, their growth rate decreases and it also affects the fertility of the animals.
